A discussion was held and both Councilwoman Crooks and Town Attorney White will research what need needs to be done to post the signs.

Jim Anderson: Any progress on the 9N project? It has not moved much since last time. The Town Board will receive a presentation from the engineer which will include public feedback. It is slow at this point. The Town Board is working on changing the speed limit near the property, Grant writer- grants take some time, and working with the engineer parallel to those.

Debbie Germain: How do we use the Noise Law; would we call the Sheriff if there is a problem? The answer to this was yes. You would also want to prove the decibels are above the limit. This can be done by using an app. on a phone.
