Dear Supervisor Butler:

CHA is pleased to present this proposal to perform continued environmental monitoring at the Town of Corinth landfill for the 2025 calendar year. As you are aware, post-closure monitoring is required by the 6 NYCRR Part 360 regulations. This proposal has been prepared in accordance with the 6 NYCRR Part 360 regulations, the conditions of the 2004 and 2008 New York State Department of Environmental Conservation (NYSDEC)-approved General Variance requests. Our proposed scope of services, schedule and associated fees are outlined in the following sections.

#### Exhibit A - SCOPE OF WORK

In accordance with the 6 NYCRR Part 360 regulations and the 2008 NYSDEC-approved General Variance request, CHA will conduct annual monitoring at the Town's landfill. The monitoring event will be conducted in October 2025. During the monitoring event, groundwater samples will be collected from three monitoring wells (DGC-1, DGC-2 and DGC-3) using dedicated polyethylene bailers and laboratory-provided sample containers. A surface water sample will also be collected from sampling location SW-1, using a disposable plastic beaker and laboratory-provided sample containers. One field duplicate sample (collected from one of the monitoring wells) and a laboratory-provided trip blank sample will also be submitted to the laboratory for Quality Assurance/Quality Control purposes. All samples will be submitted to a qualified laboratory, certified under the New York State Department of Health's Environmental Laboratory Approval Program (ELAP) to perform the required analyses. Samples will be analyzed for the 1988 Part 360 baseline scan parameters.

In the annual post-closure environmental monitoring report for 2024 submitted to NYSDEC on December 10, 2024, CHA on behalf of the Town requested the elimination of landfill gas monitoring requirements. Currently CHA has not received confirmation from NYSDEC that the landfill gas monitoring requirements can be discontinued. Therefore, in addition to the water quality monitoring, CHA will also conduct a combustible gas survey at the site in accordance with the Part 360 regulations. Combustible gas monitoring will be conducted along the perimeter of

the landfill, utilizing temporary monitoring points and field instrumentation, in order to demonstrate that combustible gases are not migrating beyond the property boundary. Temporary monitoring points will be advanced at approximately 100-foot spacing.

CHA will prepare a Water Quality Assessment Report for submittal to the NYSDEC and the Town. The report will include a tabular summary of the analytical results, a comparison with applicable groundwater standards, an updated potentiometric surface contour map, results of the combustible gas survey and recommendations for future monitoring.

#### Exhibit B - SCHEDULE

It is anticipated that the monitoring event will be conducted in October 2025. The Annual Post-Closure Monitoring Report will be submitted to the Town and NYSDEC within 90 days from date of sample collection.

#### Exhibit C - FEE

CHA proposes to be compensated for the scope of services outlined in this proposal for the lump sum fee of \$9,900.00.
